## Montgomery County Fair Queen Contest Rules & Regulations Amanda Wehrle, Chairperson

- 1. There will be a limit of 12 queen contestants.
- 2. Contestants shall be female and a resident of Montgomery County, MO or live within Montgomery County School district for no fewer than six months.
- 3. Contestants must not have ever been married, nor had a marriage annulled. Contestants who are pregnant or have been pregnant are ineligible (State Fair Rules).
- 4. A contestant must have never been convicted of any crime or have any criminal charges pending.
- 5. Contestants must be between the ages of 16 and 21 years.
- 6. Conduct deemed to be improper and detrimental to the Montgomery County Fair and/or the Queen Contest will be reason for disqualification and dismissal by the Chairperson.
- 7. Each contestant must have a sponsor. A sponsor can be a business, organization, or individual. A \$125 sponsor fee is due at the time of application. Checks payable to Montgomery County Fair Queen Contest.
- 8. All contestants are required to sell season passes for the 2024 Montgomery County Fair to participate in the competition.
- Each contestant will be required to attend all Pre-Fair Events, the coronation, and ALL preselected activities/events during
  the week of the fair. For each event that you do not attend, points will be deducted from your final score the night of
  coronation (Pre-Fair Events).
- 10. All contestants are required to wear their sponsorship banners and t-shirts to all Pre-Fair Events as well as activities/events during the week of the fair, regardless of competition placement.
- 11. Should the fair queen fail to complete her term, the title will be passed to the runner-up, in order of rank, beginning with the first runner-up.
- 12. Selection of the Montgomery County Fair Queen will be based upon the following categories: Personal Interview, Talent or Speech, Evening Wear, and Final Question. This will be in addition to your Pre-Fair Events score.
- 13. Contestants will be judged on poise, appearance and personality within each category of competition.
- 14. All contestants are to be available immediately following the coronation for publicity photographs.
- 15. The Montgomery County Fair Queen will have the opportunity to represent Montgomery County in the Missouri State Fair in August 2025 in Sedalia and other possible community functions. The First Runner-Up will participate in the queen's place, if necessary.
- 16. The Montgomery County Fair Board reserves the right to amend any rules.

**Queen:** Receives a \$1000 cash prize, plaque, sash, crown, and bouquet of flowers. (\$500 to be awarded at the end of the 2024 fair; \$500 to be awarded at the beginning of the 2025 fair)

**2**<sup>nd</sup> **Runner Up:** Receives a local boutique gift card, a plaque, sash, and a bouquet of flowers.

**Top Speech/Talent:** Receives a plaque & a local boutique gift card.
